Dear Ms. Willing:

We are writing to expose the genocide regime, human trafficking criminal racket and hypocrisy of color of law public servants, Gretchen Whitmer and Dana Nessel who have filed a deceptive, disingenuous complaint against Sidney Powell attempting her disbarment.

To the contrary, color of law government employees Nessel and Whitmer should be disbarred and criminally indicted as conspirators in a Murder for Profit Government Sponsored Guardian Racket, likely the biggest organized criminal racket in the world. This crime perpetrated against vulnerable adults in the state of Michigan and the retaliation against family members is documented in the expose below. We are educated, successful Americans, doctors, lawyers, business owners, scientists and educators, writing with regard to the crimes perpetrated by corrupt judicial public servants that is so rampant it constitutes a **NATIONAL SECURITY BREACH** and the most dangerous threat to our country. Covid pales in comparison and is used as a diversion to **the infested judicial/legal system corruption that destroys the lives of millions of American families.** American's public servants have become completely lawless as they hold themselves above the law and commit crimes with **IMPUNITY** by self-creating farcical immunity to avoid accountability.

The rampant civil unrest in our country is only an inextricably intertwined **small slice of the real cancer infecting our country:** lawless, corrupt public servant judicial employees.

Nowhere are the massive human and civil rights violations more abhorrent than in a monstrous “court” coined “guardian court” in a pretense of legitimacy where they work in collusion with the other branches of government to run a criminal enterprise under the guise of “guardianship.”

Endless, illegal “guardian laws” are enacted by corrupt legislators that are all void on their face as they violate the Declaration of Independence that states no one's rights can be encumbered or sold except in criminal matters.

These illegal void laws that profess to provide “protection” to the public are then ignored and violated by corrupt extrajudicial public servants who criminally use the illegal void laws to run a looting murder racket in the guise of “guardian/conservatorship”.

Our competent parents who have financial assets are captured in the farce of “guardianship” SOLELY FOR THE PURPOSE OF STEALING THEIR ASSETS. The “guardianship” is nothing more than an organized criminal enterprise using the courts as their base of operations by corrupt judges, attorneys, guardians and their affiliates. It has been exposed by prominent media as a human trafficking enterprise. Family members and those who comply with laws mandating they report the predators who run this racket and exercise their free speech rights to expose it are subjected to vicious retaliation, illegal void gag orders, threats, extortion, false arrest and looting and embezzlement of their assets in fake defamation lawsuits.

The Murder for Profit Government Sponsored Guardian Racket is a crime of massive proportion, no different than the Nazi genocide regime. It is the most important issue in our country. **The state of Michigan is one of the largest perpetrators DIRECTLY and INTENTIONALLY with the collusion and cover up by Dana Nessel and Gretchen Whitmer.**

THE MURDER FOR PROFIT GUARDIAN ENTERPRISE

The biggest business and dirtiest secret in America has become its government sponsored human trafficking enterprise where vulnerable affluent retired and older adults are seized by corrupt “Guardian” Judges, Attorneys and Guardians under color of law in the charade of “guardianship” to loot and embezzle their assets and cause their death by:

- a. ruling “Competent” seniors and vulnerable adults “Incapacitated”
- b. then stripping them of their **Civil Rights so they can’t fight back;**
- c. relentlessly drugging them with toxic, illegal psychotropic drugs, a chemical restraint used to drug them up so they cannot fight back or even talk;
- d. Forcibly removing them from their families;
- e. Then Judge, Attorneys and Guardians steal their entire estate, Generations of Assets, 401k’s, Social Security, Jewelry, Cars, and Homes by in the guise of fake fees that they orchestrate for the time they spend perpetrating these crimes;
- f. after everything is stolen, they are put to death by toxic doses of these illegal psychotropic drugs that contain black box warnings as they cause Sudden Cardiac Death.

These judicial/government officials who swore to uphold the Constitution and the law, instead use the courts to operate a Racketeering Enterprise where they commit crimes of Murder by Extra-judicial killing; depraved heart murder; Human Trafficking; Extortion and Fraud, The same corrupt legal system destroys families in family courts by stealing children as chattel. These crimes are widely reported in the media which produce no remedy, but only subject us and the media reporters to illegal “gag” orders; illegal “contempt” orders and false arrest.

Appellate judges violate the Constitution and humanity to protect the “Murder for Profit” enterprise. Law enforcement violates their duty to the public as they refuse to criminally investigate guardian judges and attorneys, dishonestly representing the crimes as “civil matter.” **Guardian courts are stealing between 500 Billion and a Trillion Dollars per year from our**

seniors and families by massive human rights violations and guardianship crimes. This also **steals the wealth of America and the world**. Instead of used to stimulate the American and world economy, these assets are withheld from the economy, self-contained within a small group of kingpins in this racket; money laundered and diverted to off-shore accounts. This violates the Geneva Convention as the government is pillaging from and warring with its citizens.

No one is immune from this crime. Anyone with financial assets is targeted. Members of the Pritzker and Disney families were seized in guardianship. Rupert Murdoch barely escaped. Celebrities Mickey Rooney and Casey Casem were captured in guardianship, terrorized and died in isolation as were billionaire heiresses Brooke Astor and Liliane Bettencourt. Renowned Florida artist Purvis Young was seized in guardianship by his manager who stole his paintings and assets and he died penniless.

As far back as 1987, Claude Pepper, a congressman from Florida, said of guardianships: **‘The typical [person subject to guardianship] has fewer rights than the typical convicted felon... It is, in one short sentence, the most punitive civil penalty that can be levied against an American citizen, with the exception, of course, of the death penalty.’** Claude Pepper’s statement was made at a joint hearing before the Special Committee On Aging U.S. Senate and the Select Committee on Aging U.S. House Of Representatives Ninety-Sixth Congress Second Session in Washington, D.C. on June 11, 1980 following an extensive report by that committee.

The National Council on Disability (NCD) – a federal advisory body – issued a report in March, 2018 that calls **guardianship a “civil death”**. In August, 1997, attorney Mark D. Andrews wrote “The Elderly in Guardianship: A Crisis of Constitutional Proportions” where he critiques the current guardianship establishment and concludes both constitutional and policy reasons compel the need for change in this system. He states: “Guardianship threatens to remove from the elderly the ability to make basic life decisions and to live unfettered by the control ...”

On September 30, 2010 the Government Accountability Office (GAO), a federal government agency, issued a report documenting horrific abuse of the elderly and financial exploitation.

Senator Richard Blumenthal admitted in a 2018 hearing at the select committee on aging that “these {guardian} judges made a ton of money” and “they run a fiefdom.” Rather than holding the corrupt “guardian judges” accountable and calling for their criminal investigation, instead, **he issued a corrupt bill (Public Law No: 115-70 (10/18/2017) to provide these toxic, corrupt judges with Federal Grants.**

Although the vicious retaliation being hurled against Sidney Powell and others by corrupt racketeers Gretchen Whitmer and Dana Nessel is taking place in a different context, it epitomizes the vicious retaliation and cover up racket by lawless public servants. This is far from a political issue... Sidney Powell and others sought to redress grievances as is their right under the Constitution. In fact, this right is so important that it is set forth in the very first Amendment to the Constitution. Moreover, “we the people” are mandated under the Declaration of Independence to take steps to remedy abuses as follows:

“When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle

them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.”

That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government.”

THESE CRIMES AGAINST HUMANITY WOULD NOT OCCUR BUT FOR THEIR BEING AIDED, ABETTING, COLLUDED AND CONSPIRED BY PUBLIC SERVANT EXECUTIVE AND LAW ENFORCEMENT OFFICIALS LIKE GRETCHEN WHITMER AND DANA NESSEL WHOSE PRIMARY DUTIES ARE TO PROTECT THEIR CITIZENS AND TO ENFORCE THE LAWS.

A country that does not protect its citizens' human rights is no different than a barbaric third world country. Without enforcement of the law and preservation of the core values of America's legal system, i.e.: the guarantee of life, liberty, property and the pursuit of happiness, the State of Florida is nothing more than a Nazi nation, a barbaric government and a third world country.

The public is forced to spill out into American streets DEMANDING the return of their rights.

The Murder for Profit Florida Sponsored Guardian Racket's monstrous far-reaching tentacles ensnare the entire families into its web. Once their loved one becomes entrapped in this barbaric abomination, their family members also become enmeshed. We are illegally "gag ordered" into silence; falsely arrested to retaliate against us for reporting the horrific atrocities committed and our assets are seized in fraudulent lawsuits.

These crimes are forms of war crimes under 18 U.S. Code § 2441 ; acts of domestic terrorism under 18 U.S.C. § 2331; and Crimes against Humanity under the Hague Convention. These atrocities violate the United National Universal Declaration of Human Rights and the U. N. Committee on the Rights of Persons with Disabilities and the Americans with Disabilities Act.

There is no immunity. In 200 short years, the U.S. has become a swamp of greed and power abuse, destroying rights and lives of Americans.

Outrage about massive human rights atrocities led to the resignation of judge James Dannenberg from the Supreme Court who asked Justice Roberts if the transmogrify of the United States from a republic and democracy to a government sanctioned enterprise of **bigotry, discrimination and bribery beyond redemption was complete?** The corruption tsunami in America's legal system has also been exposed by Judge John F. Molloy formerly in the Arizona Supreme Court in a book he authored entitled *The Fraternity: Lawyers and Judges in Collusion*. Justice Molloy defines "**Lawyer domination,**" stating "When a lawyer puts on a robe and takes the

bench, he or she is called a judge. But in reality, when judges look down from the bench they are lawyers looking upon fellow members of their fraternity. **In any other area of the free-enterprise system, this would be seen as a conflict of interest**” Thus, the legal system works in reverse – it protects corrupt judges and attorneys and weaponizes the public.

The guardian laws are illegal and void. They violate the Constitution; the Declaration of Independence; and the Americans with Disabilities Act. The predatory legislators, judges, executive officers and law enforcement officials including Gretchen Whitmer and Dana Nessel who are instrumental in this perpetrating this racket are criminally violating a string of federal and state law including extortion, threats, embezzlement, conspiracy, aiding and abetting and rape of rights of a class of Americans. In addition, these crimes constitute human rights atrocities as set forth above. **It is no different than Nuremberg law.**

We hereby demand the following:

- a. Contrary to taking action against Sidney Powell, that you report Gretchen Whitmer and Dana Nessel to the Director of the F.B.I.
- b. That you report these crimes by Gretchen Whitmer and Dana Nessel to the Michigan Bar Association.
- c. That you implement an urgent extensive investigation of all attorneys in the state of Texas who participate in any guardian/conservatorship matter. These attorneys **MUST BE DISBARRED** for perpetrating crimes of genocide, human trafficking, theft and other crimes of abuse and exploitation of older and vulnerable adults.
