NARRATIVE OF ATTORNEY SERVICES

I, Christopher E. Overgaard, declare as follows:

1. 18 A. 1

1. This narrative of attorney services is made pursuant to California Rules of Court, Rules 7.751 and 7.702.

2. I am the attorney for Sylvia Schmidt, conservator of the person and estate of Gertrude Gettinger, and the following is a summary of the attorney services I have performed.

3. I conferred with Sylvia Schmidt regarding the necessity of a conservatorship for Gertrude Gettinger, the alternatives to a conservatorship, and the status of Gertrude Gettinger's assets. I also discussed with Sylvia Schmidt the relatives of Gertrude Gettinger, through and including the third degree relatives.

4. I prepared the Petition for Appointment of Temporary Conservator of the Person and Estate, Petition for Appointment of Conservator of the Person and Estate, Confidential Supplemental Information Form, Confidential Conservator Screening Form, Form E-319, Citation, Order Appointing Court Investigator, Probate Case Cover Sheet, Letters of Temporary Conservatorship, Letters of Conservatorship, and Duties of Conservator. I had several conversations with Sylvia Schmidt regarding the necessity for locked placement and administration of dementia medications. I spoke with Dr. Tucker regarding the necessity for medical consent power, and dementia powers.

5. I conferred on several occasions with Violet Boskovich, the court-appointed counsel for Gertrude Gettinger. We discussed the necessity for a temporary conservator, general conservator, powers regarding medical consent, administration of dementia medication, and locked or secured placement.

6. I appeared at the hearing on appointment of temporary conservator, and had Violet Boskovich approve the Order Appointing Temporary Conservator. I walked through the Order Appointing Temporary Conservator on the day of the hearing on the temporary conservatorship, and obtained a signed copy of the Order Appointing

Temporary Conservator, and certified copies of Letters of Temporary Conservatorship. In conjunction with the Letters of Temporary Conservatorship I arranged for the bond documents to be drafted and executed.

7. I provided Sylvia Schmidt with the Handbook for Conservators, and personally reviewed the situation of the conservatee and drafted a letter to the conservator regarding her duties and responsibilities as conservator. Prior to the hearing on the permanent conservatorship, I drafted supplements to the Petition for Appointment of Conservator, and conferred with Violet Boskovich regarding the Order Appointing Probate Conservator. I appeared at the hearing on the appointment of general conservator of the person and estate, and had Violet Boskovich sign the Order Appointing Conservator. I drafted, filed and served the Order Appointing Conservator, and had Letters of Conservatorship issued.

8. I conferred with the conservator regarding the placement of the conservatee, and issues regarding her medication. I checked an internet search site to locate the conservatee's son, Robert Gettinger, and when that was unsuccessful I spoke by phone with investigator Michael Jay to assist with locating Robert Gettinger. Michael Jay was unable to locate any current address for Robert Gettinger, and the last address for Robert Gettinger was stated as 1259 Bronson Avenue, Los Angeles, California, which was the address for Gertrude Gettinger and not the address for Robert Gettinger. According to Michael Jay, the last address shown for Robert Gettinger was in 2001. Michael Jay was able to provide a social security number for Robert Gettinger, but stated that Robert Gettinger may be using a different name.

9. I reviewed documents from Sylvia Schmidt regarding the assets of the conservatee, drafted the Inventory and Appraisal, and filed the Inventory and Appraisal with the court.

10. After it became apparent that the conservatee could not continue to reside in her personal residence, I reviewed the new Code sections regarding the Care Plan for the
