17	had to sign it?

20	thought it was the right thing to do?
21	A. Yes, I did.
22	Q. Did there come a time that you became
23	aware that Tom had taken money out of a checking
24	account?

2	Q. Can you tell me whose checking account
3	that was?
4	A. It was from my father my husband.
5	Q. Your husband's checking account. Would
6	that be then Tom's father?
7	A. Also, yes.
8	Q. And when he took that money out of the
9	checking account, had he asked your permission?
10	A. No.
11	Q. Do you remember how much he took out?
12	A. I think \$30,000. That was to buy his
13	own home, and he's done more than that. Up until
14	today, he bought another home on across the street
15	on Valley Avenue in Yonkers, New York.
16	Q. So your memory is that he took a lot of
17	money out of that account?
18	A. He continues to do it too.
19	Q. You think he still might be doing it?
20	A. Yes.
21	Q. But you do know he was doing it at one
22	time?
23	A. Yeah.
24	Q. And you don't think he had your

permission or your husband's permission to take 1 2 that? No, I don't think that. He just went 3 ahead. 4 5 Now, did you -- did he ever explain to Q. 6 you why he took the money? He said he was -- he had -- he needed 7 money to make repairs on the house that he bought 8 down the street from his. 9 And did he explain to you why he wanted 10 Q. 11 to make those repairs? 12 Α. Well, he figured they were going to move into it. 13 14 When you say "they," who do you think he Q. 15 wanted to move into the house? 16 Α. My daughter and her four sons. Your daughter, meaning which daughter? 17 Q. 18 A. Karen. Karen, and her four sons. And did -- was 19 Q. 20 there any discussion as to where Joseph would live? 21 22 Joseph lives upstate. Α. 23 Q. No, I mean your --24 Or you mean my husband? Α.

15	repair it. And they're still not done after two
16	years.

7	Karen DePasquale as attorney in fact for Eva
8	DePasquale and as attorney in fact for Joseph
9	DePasquale. The actions of Karen DePasquale were
10	unilateral and inappropriate. Despite the fact
11	that she and her brother Thomas DePasquale were
12	named jointly on the durable general powers of
13	attorney, she did not consult with Thomas or seek
14	to have him join the join in these conveyances.
15	Q. Okay. You read you read quite a bit,
16	and do you feel you understood what you just read?

19	you know that Karen executed a deed transferring
