Certify record from Register of Wills to court - Will contest – Motion to quash subpoena

- 1. Whenever a caveat shall be filed or a dispute shall arise before the register concerning the probate of a will, the grant of letters or the performance of any other function by the register, he may certify, or the court upon petition of any party in interest may direct the register at any stage of the proceedings to certify, the entire record to the court, which shall proceed to a determination of the issue in dispute.
- 2. No letters of administration pendente lite shall be granted by the register after proceedings have been removed to the court except by leave of court.
- 3. All wills shall be proved by the oaths or affirmations of two competent witnesses and in the case of a will to which the testator signed his name, proof by subscribing witnesses, if there are such, shall be preferred to the extent that they are readily available, and proof of the signature of the testator shall be preferred to proof of the signature of a subscribing witness.
- 4. To prevail over the presumption and establish the existence of a lost will, the proponent of the copy of the will must prove that: (a) the testator duly and properly executed the original will; (b) the contents of the will were substantially as appears on the copy of the will presented for probate; and (c) when the testator died, the will remained undestroyed or revoked by him.
- 5. A party does not have the right to compel a witness to bring privileged materials to a hearing in case he might need them to refresh his recollection.
- 6. This case is a will contest among siblings who disagree over which will is operative. This court will schedule a hearing to determine which of the two wills is legally operative. Attorney Fischer filed a Motion to Quash Subpoena to Produce Documents and averred the materials sought were protected by the attorney client privilege. Michael Bush responded the attorney client privilege does not apply because he is named as the Executor. The Court directed Mr. Fischer to produce a privilege log and produce the will. Attorney Fischer also filed a Motion to Quash Subpoena to Produce Documents served by Mary Bush on the same ground. Mary Bush responded he should bring documents in case he needed to refresh his recollection. This Court noted that was not a basis to seek documents at a hearing and granted Mr. Fischer's Motion. Mary Bush also filed a request for discovery, seeking records of the decedent's care, funeral, etc. The Court denied the request without prejudice for her to make a narrower request.

AND NOW, this 20th day of July, 2022, after a status hearing held on July 12, 2022 and for the reasons set forth in the accompanying Memorandum it is hereby **ORDERED** as follows:

- 1. A one-day evidential hearing on the Caveat filed June 23, 2021 is scheduled for Monday, September 19, 2022 at 9:30 a.m. in Courtroom 12 of the Chester County Justice Center, 201 West Market Street, West Chester, PA 19380.
- 2. The Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order filed by Jay G. Fischer, Esquire on October, 18, 2021 is **DENIED** as explained by the accompanying Memorandum.
- 3. The Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order filed by Jay G. Fischer, Esquire on November 4, 2021 is **GRANTED** as explained by the accompanying Memorandum.

The Motion to Set Aside the Order of November 5, 2021 signed by Michele Vaughn on Mary Bush's Motion to Strike the Caveat with Prejudice with a Motion for Request of Discovery Necessary Before the Caveat Hearing filed by Mary Bush on November 12, 2021 is **DENIED** as explained by the accompanying Memorandum.

MEMORANDUM

This case is a will contest. This case concerns disputes among siblings as to the disposition of the Estate of Genevieve Bush who passed away on June 16, 2021. Michael Bush and Joseph Bush claim that the legally operative will was executed by Genevieve Bush on February 14, 2004. Mary Bush claims that the legally operative will was executed on December 5, 2007. This court held a status hearing on July 12, 2022 upon grant of the Motion to Hold a Call of the List Hearing for the Matter of the Estate [of] Genevieve Bush – Deceased filed by Michael Bush on May 19, 2022.

At the hearing, the undersigned noted the contentious history among the parties and the general procedural irregularity of this case and suggested that it would be efficient for the court rather than the Register of Wills to preside over these proceedings in the future. Agreement was expressed by the parties in attendance, namely, Mary Bush, Michael Bush, and Joseph Bush. This court announced that all undecided motions and/or petitions would be decided on the papers where possible but that an evidential hearing on undecided motions would be scheduled if necessary.

BACKGROUND

This court reviewed the file maintained by the Clerk of the Orphans' Court. No Petition for Probate and Grant of Letters has been filed however Michael Bush and Joseph Bush filed a Caveat on June 23, 2021 averring that Mary Bush intends to offer for probate a will dated December 5, 2007 which is legally inoperative because Genevieve Bush was not of sound disposing mind, memory, or understanding. Michal and Joseph Bush also averred that the will dated December 5, 2007 is legally inoperative because it was procured by Mary Bush who exerted undue and overmastering influence. Along with that Caveat, Michal Bush and Joseph Bush posted a Caveat Bond of \$5,000.00.

On June 28, 2022, this court granted the Emergency Petition to Protect and Preserve Estate Funds filed on June 24, 2021 by Michael Bush and Joseph Bush and ordered the Estate assets of \$464,891.18 held in escrow in the IOLTA account held by Lamb McErlane PC.

On September 2, 2021, the Register of Wills issued a Hearing Scheduling Notice setting November 12, 2021 for a hearing to probate the will of Genevieve Bush and to issue letters.

On October 20, 2021, Michael Bush filed a Memorandum of Law in Support of Request to Refuse Probate of Writings Presented by Mary Bush and to Receive Mrs. Bush's Last Will and Testament Dated February 14, 2004 for Letters of Administration. A copy of the will dated February 14, 2004 was attached. Among other things, Michael Bush argued that the issue whether Genevieve Bush possessed testamentary capacity after 2004 is *res judicata* as having already been determined by the Honorable Katherine B.L. Platt in her June 24, 2011 Decision and Order

filed in 1509-1720 which concerned Genevieve Bush's legal incapacity and Guardianship of her Person and Estate.

On October, 18, 2021, Jay G. Fischer, Esquire filed a Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order. Mr. Fischer averred that Michael Bush had served a subpoena on October 14, 2021 to obtain materials related to Genevieve Bush's will dated February 14, 2004. A copy of that subpoena was attached and it provided in pertinent part as follows:

Within twenty (20) days after service of this subpoena, you are ordered by the court to produce the following documents or things: All documents, in whatever form, pertaining to the will of Genevieve Bush dated on or about February 14, 2004 including but not limited to: originals, copies, notes about, correspondence about, about [sic] the will's disposition[,] archival storage, destruction, mutilation, release, transfer, etc. at 708 Shadeland Ave., Drexel Hill, PA 19026.

Motion, 10/18/2021, Exhibit "A."

The subpoena directed Mr. Fischer to produce the materials to Michal Bush at his residence. Motion, 10/18/2021, Exhibit "A."

Mr. Fischer rested his Motion on his claim that the materials sought were generated in connection with, and for purposes of, his legal representation of Genevieve Bush. *See* Motion, 10/18/2022, ¶¶ 9-12. Michael Bush filed his Response on October 28, 2021. Michael Bush established that Mr. Fischer has the original February 14, 2004 will by the letter he attached dated December 20, 2005 by which Mr. Fischer represented that he is safeguarding the will dated February 14, 2004. Response, 10/28/2021, Exhibit 3. Michael Bush argued that the attorney client privilege does not apply because he is named in the February 14, 2004 will as an Executor and in support of that claim he attached emails by which Mr. Fisher represented that he gave the December 5, 2007 will to Mary Bush on June 22, 2021 because she is named in it as personal representative with the consequence that the attorney-client privilege does not apply. Response, 10/28/2021, Exhibits 2, 4.

On November 4, 2021, Jay G. Fischer, Esquire filed a Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order. Mr. Fischer averred that Mary Bush had served a subpoena on him on October 25, 2021 to appear at the hearing scheduled for November 12, 2021 before the Register of Wills and to bring with him "communications/work product/notes/documents of you and your client Genevieve Bush[/] also deposition you gave." Motion, 11/4/2021, ¶ 1; Exhibit "A." Mr. Fischer rested his Motion on his claim that the materials sought were generated in connection with, and for purposes of, his legal representation of Genevieve Bush. *See* Motion, 11/4/2022, ¶¶ 6-10. Mr. Fisher's Motion was referred to this court which issued an Order/Rule to Show Cause on November 5, 2021 and continued the hearing scheduled before the Register of

Wills to be rescheduled in due course. Mary Bush filed her Response on November 12, 2021. Mary Bush averred that Mr. Fischer is mistaken, that she subpoenaed him merely to testify at the hearing before the Register of Wills, that she does not seek access to documents, and that she merely asked Mr. Fischer to bring the documents in case he should need to refresh his recollection. Response, 11/12/2021, p.1 (Statement of Facts); ¶ 10.

On November 12, 2021, Mary Bush filed a Motion to Set Aside the Order of November 5, 2021 signed by Michele Vaughn on Mary Bush's Motion to Strike the Caveat with Prejudice with a Motion for Request of Discovery Necessary Before the Caveat Hearing. By that Motion, Mary Bush averred that Michael Bush and Joseph Bush filed a Caveat on June 23, 202, that she filed a Motion to Strike that Caveat on November 3, 2021, and that the Register of Wills entered an order two (2) days later on November 5, 2021 denying the Motion to Strike the Caveat. Mary Bush also asked for various sorts of discovery. Mary Bush's request for relief was as follows:

Wherefore Mary Bush respectfully request[s] the Honorable Court to set aside [the Register of Wills'] November 5, 2021 Order until further Discovery takes place. That Joseph Bush submit to all parties a full accounting in all his activities as Guardian of the Estate with all supporting documents for any and all transactions, sales, income, purchases, billings, tax returns, social security payments, and bank/investment statements. That Joseph Bush be Ordered not to drive the F 150 truck. That Michael Bush submit any and all documents, records, [or] emails he has in his possession of Genevieve Bush['s] care, medical conditions, nursing home correspondences, notes, emails, from November 2018 [to the] present. Including Michael Bush's documents emails in connection with Della Vecchia, Reilly, Smith & Boyd Funeral Home, Inc. Also that the Court order the production of medical documents/records of Genevieve Bush from Park Lane at Bellingham now known as The Watermark at Bellingham, 1615 Boot Rd, West Chester, PA 19380 and from Green Meadows Rehabilitation & Nursing Center, 283 E. Lancaster Ave, Malvern, PA 19355 be provided to Mary Bush who will provide Michael Bush with [an] electronic copy of the documents.

Motion, 11/12/2021, p. 4.

On November 17, 2021, Michael Bush filed his Response to Mary Bush's Motion to Set Aside which he styled as a Motion to Deny.² First, Michael Bush asked

this court to deny Mary Bush's Motion to Set Aside arguing that its first request is essentially an appeal from, or a motion for reconsideration of, the order entered by the Register of Wills refusing to Strike the Caveat. Second, Michael Bush asked this court to deny the remainder of Mary Bush's requests for relief because they are irrelevant to the will contest at issue in the present case docketed at 1521-1459 but instead pertain the case now resolved docketed at 1509-1720 pertaining to the legal incapacity of Genevieve Bush and the Guardianship of her Person and Estate. On November 24, 2021, Mary Bush filed her Response to Michael Bush's Response to her Motion to Set Aside arguing essentially that the issues she has raised are relevant and that discovery is generally permitted in will contests.

DISCUSSION

The Decedents, Estates and Fiduciaries Code provides that "[w]henever a caveat shall be filed or a dispute shall arise before the register concerning the probate of a will, the grant of letters or the performance of any other function by the register, he may certify, or the court upon petition of any party in interest may direct the register at any stage of the proceedings to certify, the entire record to the court, which shall proceed to a determination of the issue in dispute." 20 Pa.C.S. § 907 (Certification of records to court). Here, the Register of Wills has certified this will contest to the court for decision in the first instance and the parties in attendance at the status hearing are in agreement. Accordingly, this court will schedule a hearing to determine which of the two (2) wills is legally operative.

The first of the pending Motions is the Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order filed by Jay G. Fischer, Esquire on October, 18, 2021. The Motion asserts that all materials sought by Michael Bush are protected from discovery by the attorney-client privilege. This court's reading of Michael Bush's request confirms that he seeks from Mr. Fischer materials that may well be within the scope of the privilege. Instead of producing those materials to Michael Bush, Mr. Fischer shall instead produce a privilege log. However, the attorney-client privilege pertains to communications between attorney and client and the original will dated December 5, 2007 is not a communication but rather a legal document. As such it is not within the scope of the privilege and since the copy filed of record names Michael Bush as an Executor this court can see no reason why Mr. Fischer ought not produce the original⁴ to Michael Bush as he did to Mary Bush.

It is the general rule that "[a]ll wills shall be proved by the oaths or affirmations of two competent witnesses and [i]n the case of a will to which the testator signed his name, proof by subscribing witnesses, if there are such, shall be preferred to the extent that they are readily available, and proof of the signature of the testator shall be preferred to proof of the signature of a subscribing witness." 20 Pa.C.S. § 3132(1) (Manner of probate). "[T]o prevail over the presumption and establish the existence of a lost will, 'the proponent of the copy of the will must prove that: 1) the testator duly and properly executed the original will; 2) the contents of the will were substantially as appears on the copy of the will presented for probate; and 3) when the testator died, the will remained undestroyed or revoked by him." In re Estate of Janosky, 827 A.2d 512, 519-20 (Pa. Super. 2003) (quoting Burns v. Kabboul, 595 A.2d 1153, 1167–68 (Pa.Super. 1991)).

The second of the pending Motions is the Motion to Quash Subpoena to Produce Documents and/or Issue a Protective Order filed by Jay G. Fischer, Esquire on November 4, 2021. This court will grant that Motion since the subpoena was for Mr. Fischer to appear and testify before the Register of Wills on November 12, 2021 and it is now moot. In addition, this court notes that it is not persuaded that a party has the right to compel a witness to bring privileged materials to a hearing to refresh recollection during testimony just in case.⁵

The third of the pending Motions is the Motion to Set Aside the Order of November 5, 2021 signed by Michele Vaughn on Mary Bush's Motion to Strike the Caveat with Prejudice with a Motion for Request of Discovery Necessary Before the Caveat Hearing filed by Mary Bush on November 12, 2021. The relief requested, as set forth above, makes clear that Mary Bush asked for discovery in anticipation of a hearing and that she did not object to the holding of the hearing itself. Regarding the request for discovery, this court agrees with Michael Bush that the request for information is broader than that which would pertain to a hearing to probate a will and issue letters and this court will deny the Motion without prejudice to Mary Bush's right to make a request for discovery narrower in scope.

Accordingly, for the reasons set forth above this court will enter the order set forth above.

⁵ The grant of Mr. Fischer's Motion is without prejudice to Mary Bush's right to ensure Mr. Fischer's appearance to testify before this court by appropriate means as authorized by law.

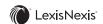


